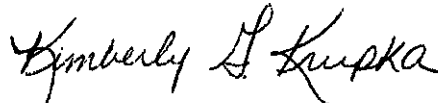

CERTIFICATE OF SATISFACTION

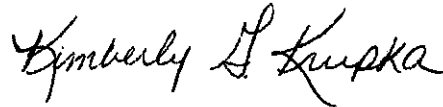
1. Complainant is Shirley Musser.

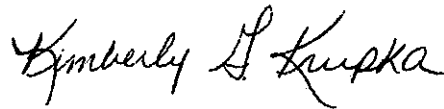
