Dear Ms. Gregg:

Per your conversation with Senior Regulatory Assessor, Teresa Ferrier, this letter confirms the settlement of the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve your formal complaint as follows:

- (1) PECO Energy has agreed to cancel late fees on your account totaling \$27.73;
- (2) PECO Energy has agreed to credit the \$75.00 reconnection fee to your account;
- (3) PECO Energy will reinstate your payment agreement. Under the agreement, you are to pay \$16.67 per month plus the monthly budget bill.

This letter memorializes the entire agreement between Kathleen Gregg and PECO Energy Company. Any other terms or promises, written or oral, not in the body of this letter will not be a part of this settlement agreement and, therefore, will be void.

I will also forward a Certificate of Satisfaction to the PUC to inform them of our agreement. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will sufficiently confirm to the PUC that the Complaint has been settled and the file will be closed.
