\*I am Donna Millan (Butts) I have recently legally changed my name. (See attached form). I am currently married to Steven Butts who has not earned any revenues by transporting Amish since 2008.

\*He moved out of our home in April 2009, and rented an apartment.

\*He re-located to Florida September 2012 He claims he will never return to Pa.

\*My understanding is that he has not earned, revenues, and therefore he does not owe assessments.

\*I realize there are unpaid assessments, and due to my husbands negligence, they're fines added to the assessments. He is unable to pay, and is very uncooperative. He refuses to discuss this matter with me.

\*I am scheduled for two major surgeries this winter (2012-2013) one November 28<sup>th</sup>, and one in February.

\*My daughter and I (when physically able) would like to transport Amish who have personal convictions that prevent them from owning or operating motor vehicles from points in Lancaster County to points in Pa and return.

\*Our desire is to work under Steve's license with the PUC. This will ease the stressful process of re-applying, going to hearings due to Krapf's contesting etc.

\* I am requesting the commission with this petition for complete debt relief, and forgiveness, and a "clean slate" for this license number A00122545.

\*We have the PUC number posted on each side of the van. It would be very difficult and costly to remove them, and put up a new PUC number. I am low income and each penny is valuable to our family. We live extremely frugally since he took his income with him.

\*In Addition, I am requesting a waiver of the age requirement. My daughter is eighteen years old. She has driven to TN, VA, OH, NC, on numerous occasions and has not received any citations or been involved in any accidents. She has extensive experience driving in all climates and topographies. She is cautious, careful, and never texts or talks on the cell phone while operating a vehicle.

\*Her brother was instantly killed due to a motorcycle accident on April 11,2010. This instilled a healthy fear into her. She is the safest driver I know. She possesses quick judgment, and I have taken her through Drivers Education.

\*She does not drink alcohol, smoke, and is not a recreational drug user. She is a good, Christian girl with very high morals and convictions. She is safe on the roads.

\*Majority of her driving is done during daylight hours.

\*Since I am unable to drive 2-3 months after each surgery, I need her to earn some income to help us pay bills.

\*She will only drive part-time. I need her as my personal assistant, and to clean, cook, and give child care and supervision to her younger siblings.

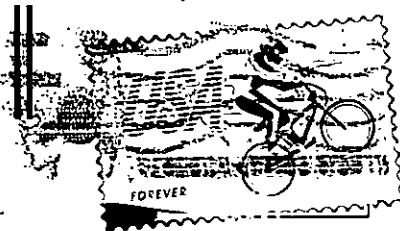
