Mrs. Poole filed a claim for damages and provided a detailed estimate of charges for the damages as Respondent requested. Mrs. Poole contracted with Grimes Interiors who provided her with a detailed estimate of \$4,113.08 dated October 19, 2005. Respondent insisted that their repairman, Bill Ireland, provide an estimate for the damages and make the repairs to the furniture. Due to conflicting schedules, the estimate did not take place until March 13, 2006. Respondent told Mrs. Poole that they would be responsible for the difference in cost between their repairman and Mr. Ireland's estimate. Mrs. Poole contacted the respondent by letters dated March 7, 2006, March 22, 2006 and April 10, 2006, prior to seeking legal action. A settlement of \$1,000.00 was made after Mrs. Poole retained legal counsel. Respondent failed to act promptly upon written or oral communications with respect to Mrs. Poole's insurance claim and did not attempt to effectuate a prompt, fair and equitable settlement of her claim. The Bureau alleged at Paragraph Four that respondent, by failing to acknowledge and act promptly upon written or oral communications with respect to insurance claims, and by not attempting to in good faith to effectuate prompt, fair and equitable settlement of claims in which the carrier's liability has become reasonably clear, violated 52 Pa.
