In reply to your letter dated December 12, 1988. File A99993,  $\times/IC-88-404$ .

Our correct name filed with the Penna. P.U.C. is Stumpf Moving and Storage Company not B.F. Stumpf.

We have received a supply of 'Information for Shippers' and will leave one at each estimate. We still have not seen these forms at customers homes and you can be sure customers leave estimates from other movers around to let us know that they have received other estimates.

We are luckly if we receive two or three prepared moving during the year. Customers rarely accomplish what they say they are going to do and very few would admit that the actual moving was different from the amount shown at estimate. When the customer fails to pay any additional amount after 15 days, what support is the PUC going to give the mover? We will have the extra expense of going to a magistrate.

Attached is a copy of two business cards of people doing business as movers in this area. We would like to know their PUC permits and insurance coverage. We would also like to know the status of Moving Services Unlimited as to their PUC application and insurance.







Stumpf's automobile coverage is written with the New Hampshire Insurance Group under policy No. CPO 142 14 94. The policy is effective as of December 29. 1988 for a period of one year. For your convenience I am enclosing a copy of that policy.
