PETITION TO WITHDRAW COMPLAINT

AND NOW, comes Logan Township, and by its attorneys, Goldstein, Heslop, Steele, Clapper, Oswald & Smith, and pursuant to 52 Pa. Code §5.94, files this Petition to Withdraw Complaint, and avers as follows:

1. On or about August 16, 2012, Logan Township ("Township"), by and through its Manager Timothy B. Brown, filed a Complaint with the Public Utility Commission against Peoples Natural Gas Company LLC (Peoples) related to its failure to obtain a permit prior to digging up a Township road during one of its projects.

2. The Township also filed a citation against Peoples for violation of Chapter 21, Section 101 of its Code of Ordinances which requires individuals and entities to obtain a permit prior to digging up a Township road.

3. Upon being served with the citation, Peoples made application for the required permit and paid the fine for the Ordinance violation, including restitution for damage to the road.

4. As a result of Peoples' actions, the Township has obtained its desired goal of compliance with its Ordinance any restitution for the damage that was done to its road.

5. Because the Township has obtained the relief sought in the Complaint, it is no longer necessary to pursue this matter further.

6. Logan Township requests that its Complaint of August 16, 2012 be withdrawn.

WHEREFORE, Logan Township requests that the Complaint filed against Peoples Natural Gas LLC be withdrawn and the docket in this matter be marked discontinued, satisfied and ended.



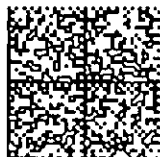
