
The proposed revisions list on 3rd Revised Page 42 to Tariff Freight Pa. P.U.C. No. 54 for Gardner Moving Company the addition of four Pa. Counties (i.e. Beaver, Butler, Washington and Westmoreland) to its existing Allegheny County. This change is made necessary by the approval of the Commission at Public Meeting held September 13, 2012 transferring household goods in use operating authority from Frontier Van Lines Moving & Storage, Inc. at A-00122436.

The proposed loose-leaf revisions are being filed on sixty (60) days advance notice, except as otherwise provided. The newly published counties are effective on one (1) days notice or October 3, 2012 under authority of Pa. Code, Title 52, Section 23.42.
