

NEW INFORMATION/PRELIMINARY OBJECTIONS/RESPONSES

IN RESPONSE TO THE PECO NEW MATTER I WOULD LIKE TO RESPOND ACCORDINGLY.

1. I REQUEST ALL INFORMATION PROVING THE DEFAULT ON MAY 27, 2009.
2. THERE WAS NO CUSTOMER DEFAULT ON DEC 2011 AND JAN 2012. THIS WAS PECO ERROR AND PER "EXHIBIT 2" THE PAYMENTS WERE MADE ON TIME, YET PECO CUSTOMER SERVICE HAD INSTRUCTED THE CUSTOMER THE WRONG PAYMENT AMOUNT OR DUE DATE, YET PAYMENT WAS FULLY RECEIVED. FOR THE MONTHS.
3. USAGE COMPARISON FOR THE PREVIOUS YEAR SHOW HIGHER USAGE IN 2011 YET A LOWER BILLED AMOUNT COMPARED TO LOWER USAGE IN 2012 WITH A HIGHER BILLED AMOUNT .
4. PECO REP STATED REVIEWS EVERY 12 MONTHS, YET PRIOR TO THE FILING WITH THE PUC WE HAD BEEN REVIEWED TWICE IN THE LAST 6-7 MONTHS AND PECO REQUESTED INCREASED BILLING AMOUNTS.
5. PECO REPRESENTATIVES ADVISED THE CUSTOMER ON MULTIPLE OCCASIONS OF CREDIT BEING CREDITED TO THE BILL YET ONCE THE DIFFERENCE WAS PAID THERE WAS A "DEFAULT " ISSUE CONVEYED TO US BY THE SAME COMPANY THAT TOLD US WE HAD A CREDIT AND ADVISED US OF THE PAYMENT TO SEND IN THE FIRST PLACE.
6. ALL PAYMENTS WERE MAILED ON TIME TO PECO AND THE AMOUNT PAID WAS REMITTED IN FULL ACCORDING TO THE INFORMATION FOR THE PECO REPRESENTATIVE AND/OR BILL IF WE RECEIVED ONE.
7. AS STATED PREVIOUSLY WE WERE NOT RECEIVING BILLS MONTHLY FROM PECO AND HAD TO CALL IN TO DETERMINE THE AMOUNT AND DUE DATE.
8. THE DEFERRED AMOUNT IS EXTREMELY LOWER PERCENTAGE WISE TO THE AMOUNT BILLED FOR MONTHLY USAGE AND SEEMS TO DEFLECT THE ISSUE OF WHAT OUR COMPLAINT IS ABOUT.
9. THE CUSTOMER HAS PAID PECO EVERY MONTH AND HAS NOT MISSED A PAYMENT SINCE THE FILING OF THE COMPLAINT AND REQUEST PUC TO INTERVENE AND ARRANGE A RESPECTABLE, AGREEABLE, AND INCOME SENSITIVE REPAYMENT PLAN FOR THE ACCOUNT.

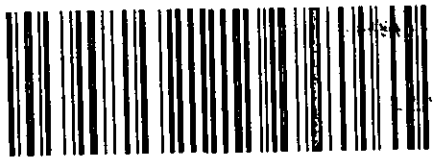

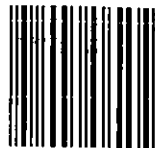

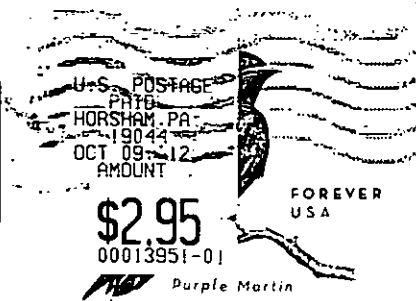
