May 31, 2012 J-Line Inc. ceased all operations. Our drivers and customers all went to Synergistiks Inc. Salex, PA. PA P.U.C. A-00121358, DOT 1307025 as of June 1, 2012.

This Policy was extended by Sentry Insurance thru September 21, 2012 and then until October 31, 2012. Apparently they did not file extension with you. Copy of latest extension attached.

We have continued Insurance Coverage and have not been in violation although we have been out of business since May 31, 2012. Our facility at 265 Brush Mountain Road is sold and final settlement is between not and October 12, 2012.



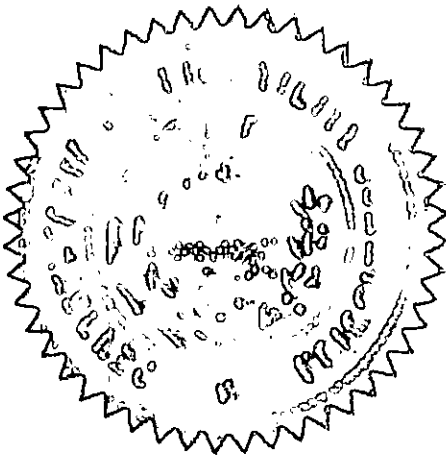

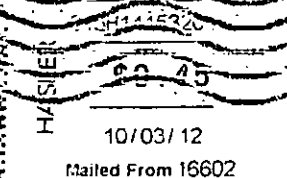
