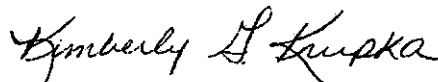

 - (b) Complainant withdraws her Complaint.

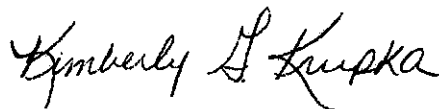
