Dear Secretary Chiavetta:

By Secretarial Letter issued on October 4, 2012, the Pennsylvania Public Utility Commission ("Commission") directed the parties to the above-captioned proceeding to submit supplemental briefs and technical evidentiary affidavits by November 5, 2012, and reply briefs by November 26, 2012.

The purpose of this letter is to respectfully request an extension of the supplemental briefing deadlines set forth in the October 4, 2012 Secretarial Letter. Core Communications, Inc. ("Core") has several significant document submissions due on and around the first week of November, including testimony in a highly technical ongoing formal complaint proceeding and a brief in the *USF/ICC Transformation Greter*¹ appeal pending in the United States Court of Appeals for the 10th Circuit. As a result, the Core personnel who will be preparing the supplemental briefs and evidentiary affidavits will have limited availability until those document submissions are concluded.

Core's counsel has discussed the possibility of an extension with counsel for Windstream, and Windstream has indicated that it is agreeable to an extension. Furthermore, the parties have agreed to confer regarding the possibility of resolving some or all of the contested


