

Disclosure Statement

THIS STANDARD SERVICE AGREEMENT ("Agreement") will authorize Discount Energy Group, LLC to serve as the undersigned Customer's retail electricity supplier in the Local Utility territory of PECO. The services provided by Discount Energy Group to the Customer are governed by the terms of this Agreement

Background

Discount Energy Group, LLC is licensed by the Pennsylvania Public Utility Commission to offer and supply electric generation services throughout Pennsylvania. Our PUC license number is A-2010-2199551.

Generation prices and charges are set by the electric generation supplier you have chosen. The Public Utility Commission regulates distribution prices and services. The Federal Energy Regulatory Commission regulates transmission prices and services.

You will receive a single bill from your Electric Distribution Company for both its charges and for our charges.

Right of Rescission - You may cancel this agreement at any time before midnight of the third business day after receiving this disclosure. To rescind this Agreement, please call DEG toll-free at 800-282-3331.

Definitions:

- **Generation Charge** - Charge for production of electricity.
- **Transmission Charge** - Charge for moving high voltage electricity from a generation facility to the distribution lines of an electric distribution company.
- **Initial Term** - The one (1) year period by which you agree to purchase your electric generation service from Discount Energy Group, LLC ("DEG") at the rate disclosed below.
- **EDC** - Electric Distribution Company
- **DEG** - Discount Energy Group, LLC

Terms of Service

1. Basic Service Prices - Your initial variable contract price for generation supply charges is \$0.XXX per kWh. This variable contract price includes Electric Generation Service Charges, Transmission Charges and Estimated Total State Taxes including Gross Receipts Tax, but excludes applicable state and local Sales Taxes. The variable contract price will be adjusted monthly based on conditions in the electricity markets. The variable contract price could be higher than the EDC price.

2. Length of Agreement - This Agreement codifies that you will purchase your electric generation service from Discount Energy Group. The term of this Agreement will begin on a date set by your Electric Distribution Company and will continue thereafter for a period of one (1) year, hereto known as the "Initial Term."

3. Penalties, Fees and Exceptions - There are no penalties, fees or exceptions

4. Cancellation Provisions – You have the right to cancel this agreement for any reason, at any time, without penalty. You may cancel your service by contacting DEG toll free at 800-282-3331. When you cancel services, you agree to pay for the services provided by Discount Energy Group, LLC through the date you are switched to another EGS or returned to the EDC for service. Your cancellation will not be effective until the next regularly scheduled meter-reading date which follows the date on which Discount Energy Group, LLC, gives the EDC notice of your cancellation request. You are responsible for all charges incurred through the date on which cancellation is effected by the EDC.

5. Non-Payment – If your electric service is terminated by your electric distribution company, then this agreement is cancelled on the date that your electric service is terminated. You will owe us for amounts unpaid for our charges for electric generation service up to the date of termination.

6. Renewal Provision / Agreement Expiration / Change in Terms – If you have a fixed term agreement with us and it is approaching the expiration date or whenever we propose to change our terms of service in any type of agreement, you will receive written notification from us in each of our last three bills for supply charges or in corresponding separate mailings that precede either the expiration date or the effective date of the proposed changes. We will explain your options to you in these three advance notifications.

7. Dispute Procedures – You can contact us through our toll-free number or via our website as outlined below with any questions concerning our terms of service. You may call the PUC if you are not satisfied after discussing your terms with us.






