
THEREFORE,

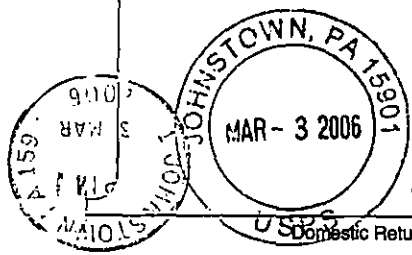
