2 ADMINISTRATIVE LAW JUDGE MARLANE CHESTNUT: This  
3 is the hearing scheduled at Docket C-20054920, Anita Willem  
4 versus PECO Energy. For the record let me state that I am  
5 Administrative Law Judge Marlane R. Chestnut. I will note the  
6 following appearance for the record: Lisa Lutz, representing  
7 Respondent.

8 As I indicated to Ms. Lutz and her witnesses, the  
9 hearing notices and several of the prehearing orders that we  
10 sent to different addresses have been returned and marked as  
11 undeliverable. Ms. Lutz, you indicated that your witness sent a  
12 letter, and it was not returned?

13 MS. LUTZ: That's correct, Your Honor. If  
14 Mr. Costello could give the information on the mailing.

15 JUDGE CHESTNUT: First off, what is the service  
16 address, just to be sure we're talking about the same place?

17 MR. COSTELLO: 3131 Knights Road.

18 JUDGE CHESTNUT: 3131, because on the complaint  
19 she has 3137. It's clearly 3137. That was my concern because  
20 I saw the BCS decision with 3131.

21 MR. COSTELLO: The BCS informal decision has  
22 3131. Your Honor, our company records--

23 JUDGE CHESTNUT: Do you have a copy of the  
24 complaint?

25 MS. LUTZ: Yes.

1 JUDGE CHESTNUT: Does it look like 3137 to you?

2 MS. LUTZ: It does.

3 JUDGE CHESTNUT: Doesn't it clearly look like 3137  
4 actually?

5 MS. LUTZ: Yes.

6 JUDGE CHESTNUT: So, we sent it to different  
7 variations, 3137 Knights Road, Building 5, Apartment 33, but  
8 then we thought maybe it was boulevard -- it didn't quite make  
9 sense -- but it looks like what she wrote there. So we sent  
10 that also.

11 MS. LUTZ: Okay.

12 JUDGE CHESTNUT: So, the service address is 3131?

13 MS. LUTZ: That's correct, according to the  
14 account number. According to the account number on PECO's  
15 records the address is 3131 Knights Road, 5-33.

16 JUDGE CHESTNUT: Okay. Then I think we're going  
17 to have to reschedule this.

18 MS. LUTZ: Okay.

19 JUDGE CHESTNUT: Which I guess would be consistent  
20 with Building 5?

21 MS. LUTZ: Yes.

22 JUDGE CHESTNUT: Bensalem?

23 MS. LUTZ: Yes.

24 JUDGE CHESTNUT: I think given we were sending it  
25 to 3137 I'm going to have to direct that this be re-scheduled.

1 MS. LUTZ: Okay. Your Honor, we have another  
2 address for her in New York that just came through.

3 JUDGE CHESTNUT: Why don't you give me that also  
4 please.

5 MS. LUTZ: Number 43, Lincoln Avenue, Islip,  
6 I-S-L-I-P, Terrace, New York 11752.

7 JUDGE CHESTNUT: I'm sorry to do that since you're  
8 here, but I think the only fair thing is to re-schedule and send  
9 it to both those addresses, I guess.

10 MS. LUTZ: Thank you, Your Honor.

11 JUDGE CHESTNUT: Is there anything before we  
12 adjourn?

13 MS. LUTZ: We have nothing more on that case.

14 JUDGE CHESTNUT: *Thank you very much then. The*  
15 *hearing is adjourned.*

16 MS. LUTZ: Thank you.
