Dear Mr. Peters-Thomas:

Per our conversation today, this letter confirms that you will not proceed with the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve your formal complaint as follows:

- (1) The account for service at 131 South 4th Avenue, 1st Floor, Coatesville, PA 19320 under account number 72656-65064 is currently in the name of Darrance Peters-Thomas;
- (2) The account balance under 72656-65064 is \$5,646.92;
- (3) Roger G. Thomas will sign a transfer of balance form taking responsibility for \$2,966.16 of the \$5,646.92 balance;
- (4) PECO Energy will open an account for Roger G. Thomas for service at 131 South 4th Avenue, Coatesville, PA in his own name with a balance of \$2,966.16;
- (5) PECO Energy will issue a payment agreement to Roger G. Thomas on a balance of \$2,966.16. Under the terms of the agreement, Mr. Thomas is to pay \$128.96 per month for twenty-three (23) months;
- (6) PECO Energy will send a Customer Assistance Program ("CAP") application to Roger G. Thomas;
- (7) Roger G. Thomas has agreed to complete the CAP application and send it to the attention of Dana McCollum with income verification;
- (8) If Mr. Thomas qualifies, he will be placed on the CAP program;
- (9) If PECO Energy does not receive the transfer of balance form within twenty (20) days of this correspondence, Roger G. Thomas will be added as a primary account holder with Darrance Peters-Thomas on the account number 72656-65064 with the existing balance.
