
On September 24, 1980 I received a "notice of suspension". This letter stated that you did not receive our Certificate of Cargo Insurance renewal.

This is to certify, That the Maryland Casualty Company

(hereinafter called Company) of P.O. Box 1228 Baltimore, MD. 21203

has issued to Saeger Trucking Co. of P.O. Box 767, Bethlehem, Pa. 18016

the policy of Cargo Insurance herein described which, by the attachment of endorsement, Form Number UCPC-32, approved by the Pennsylvania Public Utility Commission, has been amended to provide compensation for loss of or damage to all property belonging to shippers or consignees and coming into the possession of the Insured in connection with its transportation service under certificate of public convenience or permit issued to the Insured by the Pennsylvania Public Utility Commission or otherwise under the Public Utility Law, effective June 1, 1937, and the pertinent rules and regulations of the Pennsylvania Public Utility Commission, regardless of whether the motor vehicles, terminals, warehouses, and other facilities used in connection with the transportation of such property are specifically described in the policy or not. The Company shall not be liable for an amount in excess of \$2500, in respect of the loss of or damage to the property hereby insured carried on any one motor vehicle, whether such losses or damages occur while such property is on a motor vehicle, or otherwise. The liability of the Company extends to such losses or damages whether occurring on the route or in the territory authorized to be served by the insured or elsewhere.

Whenever requested by the Commission the Company agrees to furnish to the Commission a duplicate original of said policy and all endorsements thereon.

The endorsement described herein may not be canceled without cancellation of the policy to which it is attached. Such cancellation may be effected by the Company's or the Insured's giving thirty (30) days' notice in writing to the Pennsylvania Public Utility Commission at its office in Harrisburg, Pennsylvania, said thirty (30) days' notice to commence to run from the date notice is actually received at the office of said Commission.

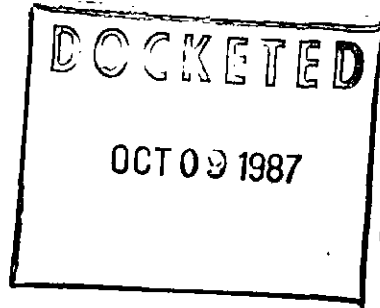
