
Verne H Alderson and James R Alderson, Alderson Valley Farm PUC # A-8913422 are no longer in business as a trucking operation.

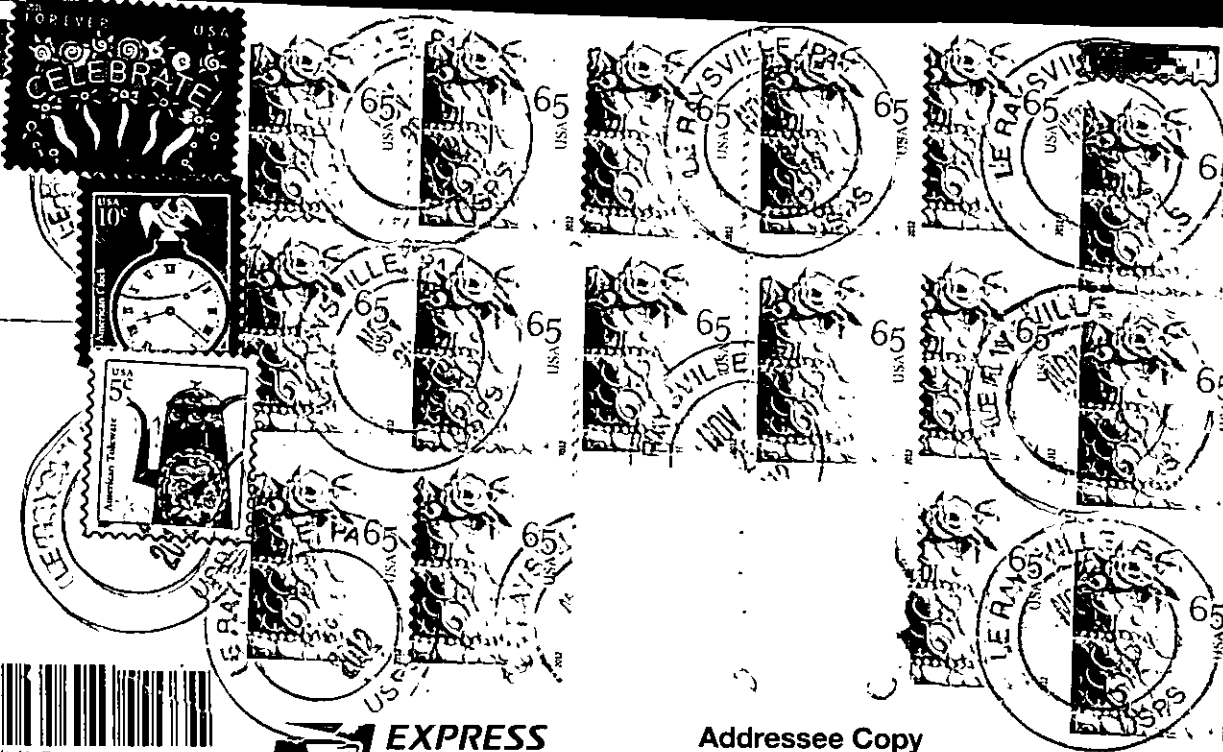
