CERTIFICATE OF SATISFACTION

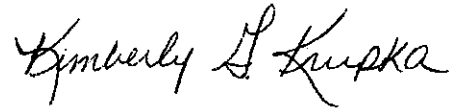
1. Complainant is Rebecca Oxenford.

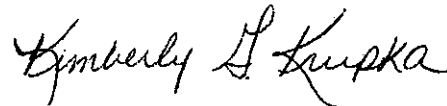
