CERTIFICATE OF SATISFACTION

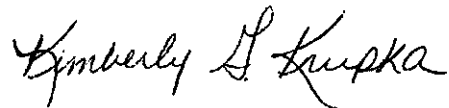
1. Complainant is Boris Batist.

 - (a) Complainant, Boris Batist, and Respondent, PPL Electric, agree that Complainant will pay \$191 by December 11, 2012. Thereafter, beginning with the bill due January 2013, Complainant shall pay his monthly bill plus \$25 per month towards arrearages, until all arrearages are paid in full.
 - (b) Complainant withdraws his Complaint.

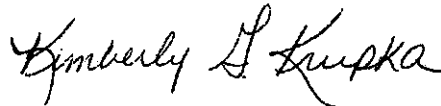
