


THEREFORE,

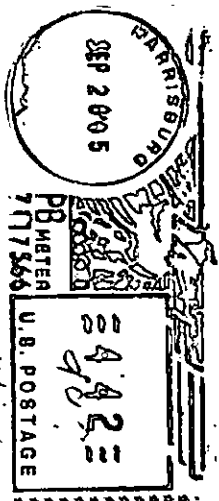
