


CERTIFICATE OF SATISFACTION

 - (a) Complainant, Yolande Reid, and Respondent, PPL Electric, agree that Complainant will pay \$109 by December 18, 2012. Thereafter, beginning with the bill due January 2013, Complainant will pay her budget bill plus \$32 per month towards arrearages until all arrearages are paid in full.
 - (b) Complainant withdraws her Complaint.


