Dear Secretary Chiavetta:

Snyder Brothers, Inc. ("Snyder Brothers") is a Natural Gas Supplier ("NGS") licensed by the Pennsylvania Public Utility Commission ("PUC" or "Commission") to serve residential, small commercial, large commercial, industrial, and governmental customers in the service territories of the following natural gas distribution companies: Columbia Gas of Pennsylvania ("Columbia"); Equitable Gas Company ("Equitable"); National Fuel Gas Distribution Corporation ("NFG"); and Peoples Natural Gas Company LLC ("Peoples"). Snyder Brothers is also authorized to serve large commercial, industrial, and governmental customers in the UGI Central Penn Gas Company service territory.

By this letter, Snyder Brothers respectfully requests a further amendment to its NGS license in order to offer, render, furnish, or supply natural gas services to all customer classes in the service territory of Peoples TWP LLC ("Peoples TWP"). For the reasons discussed below, Snyder Brothers also requests Commission approval of this proposed amendment by the February 14, 2013 Public Meeting, so that Snyder Brothers may begin serving the aforementioned customer classes in the Peoples TWP territory. Snyder Brothers has existing customers that also have facilities in the Peoples TWP service territory, to which Snyder Brothers would like to provide competitive offers.

In support of Snyder Brothers' proposed amendment, please find attached the following:

- Appendix A containing a copy of Snyder Brother's proofs of publication. Snyder Brothers published notice of its original NGS license application in the Pennsylvania newspapers as required by the Commission to provide service in the Peoples TWP service territory. Therefore, Snyder Brothers submits that additional publication regarding the present request to expand its service territory to include Peoples TWP is not required.

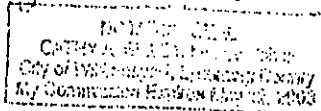
