



Pursuant to Section 5.24(b) of Title 52 of the Pennsylvania Code, 52 Pa. Code § 5.24(b), PPL Electric Utilities Corporation (“PPL Electric”), Respondent in the above-captioned matter, hereby submits this Certificate of Satisfaction. PPL Electric hereby certifies that Dr. Sauco-Helfst and it have settled the above-captioned proceeding and that the Complaint is satisfied with the settlement.

In the Complaint, Dr. Sauco-Helfst expressed concern about the type of meter that PPL Electric installed at her residence on April 16, 2011. PPL Electric has agreed to replace the mater at her premises with the type of meter that had been installed at her residence in June, 2003 through April 15, 2011. The replacement is to take place on or before December 14, 2012. In exchange for the replacement of the meter at her residence, Dr. Sauco-Helfst agreed to withdraw her Complaint with prejudice.


