The purpose of this letter is to report on the status of the above-referenced matter. On November 14, 2012, PPL Electric Utilities Corporation filed and served a letter to report on the status of this matter. Therein, the Company explained that it received a settlement proposal from Complainant, and that it was in the process of preparing a response to each of the proposals set forth in Complainant's initial settlement offer. Due to storm restoration efforts related to Hurricane Sandy, PPL Electric was delayed in completing its analysis of Complainant's initial settlement offer. Following the conclusion of the storm restoration efforts related to Hurricane Sandy, PPL Electric completed its analysis of and prepared a response to the initial settlement offer.

Today, December 13, 2012, PPL Electric sent its response to Complainant's initial settlement offer. Therein, the Company has asked that Complaint reply to its counter proposal within ten (10) business days to indicate his willingness to continue settlement negotiations. In the event that PPL Electric does not receive a response from Complainant within ten (10) business days, the Company will contact you with a status update and to schedule this matter for formal mediation or litigation as appropriate.
