1. In response to Data Request #5, financial records supplied are complete and there are no absent records. Samantha Wright is a regular employee (1099) and works a variable hourly schedule each week ranging from 12-40 hours/wk as client and business needs dictate. My wife is not shown but is an officer and handles certain financial tasks. Others shown on the website are part-time (deal by deal basis or otherwise as needed) as are several sales referral personnel not shown. We pay most personnel contingency fees in full shortly after a client is acquired to avoid paying recurring fees annually. Ms. Wright is paid bi-weekly at an hourly rate. Payroll expenses shown were for Ms. Wright and commissioned sales personnel.
2. In response to Data Request #6, corrected original Affidavits are attached. As noted in the application, the Affidavit addressing publication of newspaper notices will be sent as soon as notarized certifications of notice publications are received from the newspapers.

The Applicant acknowledges that it shall report to the Commission its jurisdictional natural gas sales for ultimate consumption, for the previous year or as otherwise required by the Commission. The Applicant also acknowledges that it is subject to 66 Pa. C.S. §506 (relating to the inspection of facilities and records).

Applicant, by filing of this application waives confidentiality with respect to its state tax information in the possession of the Department of Revenue, regardless of the source of the information, and shall consent to the Department of Revenue providing that information to the Pennsylvania Public Utility Commission.

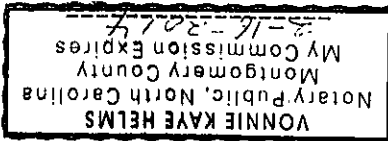

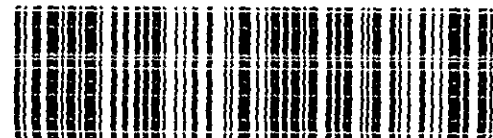
