
Dear Secretary Chiavetta:

On December 1, 2012, the Pennsylvania Bulletin published notice of PECO Energy Company Petition for Approval of its Phase II EE&C Plan which was filed with the Pennsylvania Public Utility Commission on November 15, 2012. See 43 Pa.B. 7371. That notice provided a period of 20 days for parties to submit comments to PECO's proposed plan.

PECO's Petition has been referred to the Office of Administrative Law Judge and assigned to ALJ Dennis H. Buckley for hearings and referral to the Commission for a decision. On December 3, 2012, the Coalition for Affordable Utility Services and Energy Efficiency in Pennsylvania (CAUSE-PA) filed a Petition to Intervene and a Prehearing Memorandum in this proceeding. By Order dated December 4, 2012, ALJ Buckley granted CAUSE-PA's Petition to Intervene. On December 14, 2012, The Commission issued an Order in this matter and established a procedural schedule. The procedural schedule calls for other parties to file Direct Testimony on December 21, 2012. CAUSE-PA intends to file Direct Testimony and fully participate in the litigated proceeding.

CAUSE-PA is filing this letter in lieu of comments to inform the Commission of its intent to fully participate as an Intervener in the captioned proceeding before the ALJ through the filing of testimony and briefing.


