
**Re: PPL Electric Utilities Petition for Approval of its Act 129 Phase II EE&C Plan

Dear Secretary Chiavetta:

On December 1, 2012, the Pennsylvania Bulletin published notice of PPL Electric Utilities Petition for Approval of its Phase II EE&C Plan which was filed with the Pennsylvania Public Utility Commission on November 15, 2012. See 43 Pa.B. 7372. That notice provided a period of 20 days for parties to submit comments to PPL's proposed plan. UGI Utilities, Inc. – Gas Division (“UGI”), UGI Penn Natural Gas, Inc. (“PNG”) and UGI Central Penn Gas, Inc. (“CPG”) (collectively, the “UGI Distribution Companies”), have intervened in this matter. The UGI Distribution Companies intend to present direct testimony and fully participate in the litigated proceeding in accordance with the schedule set by ALJ Buckley.

Because the notice filed in the Pennsylvania Bulletin requires the filing of comments within 20 days of its publication, UGI Distribution Companies are filing this letter in lieu of comments to inform the Commission of its intent to fully participate in the captioned proceeding through the filing of testimony and briefing.


