(a) Complainant, Robert Anderson, and Respondent, PPL Electric, agree that Complainant has paid \$51 to be reinstated to the Ontrack Program. Beginning with the bill due January 2013, Complainant will pay his OnTrack amount of \$113 per month.

(b) Complainant withdraws his Complaint.
