 - (a) Complainant, Stephen Cramer, and Respondent, PPL Electric, agree that PPL Electric will apply a credit in the amount of \$3,953.00 to Complainant's account, leaving a remaining balance of \$3,953.73. Complainant will make monthly payments of \$65.89 by the 16th day of each month, beginning with the first payment on January 16, 2013 until the balance is paid in full.
 - (b) Complainant agrees to withdraw his Complaint.
