MOTION FOR DEFAULT JUDGMENT

NOW COMES the Pennsylvania Public Utility Commission's ("Commission") Bureau of Investigation and Enforcement ("I&E"), by its counsel, and files this Motion for Default Judgment against DBH Transportation, Inc. ("Respondent") pursuant to Section 5.103 of the Commission's regulations, 52 Pa. Code §5.103. In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on September 26, 2012, by filing a Complaint and serving it by certified mail to Respondent at 1625 North 5th Street, Reading, PA 19610.
2. This is the last known address that Respondent provided to the Commission.
3. On October 19, 2012, the Complaint was returned to the Commission by the United States Post Office and was marked as "Return to Sender; Unclaimed; Unable to Forward."
4. I&E published the Complaint in the Pennsylvania Bulletin pursuant to the Commission's procedural regulations. 52 Pa. Code §1.53(e)(related to Service by the Commission).

5. The Complaint was published in the Pennsylvania Bulletin on December 1, 2012. *42 Pa. Bull.* 7372 (December 1, 2012).
6. Included with the Complaint was a Notice advising Respondent that it must file an Answer within twenty (20) days.
7. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.
8. Respondent did not file an Answer to the Complaint.
9. Respondent has not paid its outstanding assessment balance for the 2011-2012 Fiscal Year, which totals \$1,192.
10. Respondent has not paid the civil penalty that was proposed in the Complaint.
11. I&E respectfully requests that the Commission enter a Default Order against Respondent that:
 - a. Orders Respondent to pay its outstanding assessment and civil penalty;
 - b. Cancels Respondent's certificate of public convenience at A-00117202;
 - c. Notifies Respondent that a copy of this Order will be sent to the Pennsylvania Department of Transportation for the suspension or revocation of vehicle registrations that were used under Respondent's operating authority; and

- d. Directs the Bureau of Administrative Services, Assessment Section to refer the matter to the Pennsylvania Office of Attorney General for collection of the unpaid assessments.
