Count VI P.B.W. representative advised Mr. Lloyd at time of transferring service this would be done and his new bill will come in 30 days he also advised Mr. Ed Lloyd to pay partial bill when it comes in In which Mr. Lloyd did 37.00 approx.

Count VII P.B.W. is charging for Gas Service when Heater was broken and Landlord did not fix for 2 months and Mr. Edward Lloyd called and advised P.B.W. that there was no way they could have billed for the month of October/November because the Heater was broken and fixed 2 weeks ago.
