Dear Special Agent Alexander:

This letter is in response to the exhibits that were presented by PECO at my telephone hearing which took place on Monday, November 19, 2012. After reviewing these exhibits sent to me by PECO, I have to agree with PECO. The exhibits that PECO presented are accurate. I cannot dispute any of them. For several years, I have had problems with keeping up with my electric bills. Also, during the hearing, I was told that if I paid the required monies that I owed when I was on the CAP program, that I could be put back on the program. But I was also told that this would not resolve my PECO problem. At this point, I am confused as to what exactly would solve my PECO problem. I was under that impression that with an agreement and CAP reinstatement, I could clear up my back bill and get back on track as to keeping up with my PECO bill.

As stated at the hearing, I am a brittle diabetic and have been prescribed two different kinds of insulin and other medications that require a \$25.00 co-pay on each. Every month, I must buy these medications and sometimes I do have to decide to pay a bill, buy food, or buy my medications. I now have a 21 month old grandson who is asthmatics; he has to use a humidifier and a nebulizer. I know that PECO has given me several really good agreements that in the past I have not been able to keep and I am also aware that if PECO should afford me another agreement, that this will be the last one for me. With all of this in mind, I am asking for another affordable agreement from PECO so that I can keep my electricity on and also clear my bill to a zero balance.

Thanking you in advance for your kindness and consideration in this matter.
