Pursuant to the provisions of its Alternative Regulation and Network Modernization Plan, approved by the Pennsylvania Public Utility Commission at Docket No. P-00961024, Frontier Communications Commonwealth Telephone Company ("Frontier Commonwealth") respectfully informs the Commission that on February 1, 2013, it will submit its annual Price Stability Index/Service Price Index filing. At this time, it is anticipated that Frontier Commonwealth will request a \$1.89 increase to existing residential dial-tone rates on February 1, 2013.




