Dear Mr. Ohrenstein:

This letter confirms the settlement of the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve Mr. Kornhauser's formal complaint as follows:

- (1) Mr. Kornhauser's current balance is \$1,865.45;
- (2) PECO Energy will credit \$221.25 in late payment charges to Mr. Kornhauser's account;
- (3) PECO Energy will offer Mr. Kornhauser a twenty-four (24) month payment agreement. Under the agreement, Mr. Kornhauser would pay \$68.51 plus the current monthly utility bill for 24 months.
- (4) Mr. Kornhauser will issue a check to PECO Energy in the amount of \$209.26 to bring his account current.

This letter memorializes the entire agreement between Murray Kornhauser and PECO Energy Company. Any other terms or promises, written or oral, not in the body of this letter will not be a part of this settlement agreement and, therefore, will be void.

I will also forward a Certificate of Satisfaction to the PUC to inform them of the status of this complaint. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will sufficiently confirm to the PUC that the Complaint has been resolved and the file will be closed.
