Per our conversation today, this letter confirms the resolution of the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve your formal complaint as follows:

- (1) On September 26, 2012, you filed for Chapter 7 Bankruptcy in the Eastern District of Pennsylvania at docket number 12-19088-jkf.
- (2) On January 2, 2013, PECO Energy charged of your balance in the amount of \$8854.48.
- (3) You now have gas and electric service under account number 41858-96006. You currently have a \$615.71 balance on your account.

This letter memorializes the entire agreement between Moses Bryant and PECO Energy Company. Any other terms or promises, written or oral, not in the body of this letter will not be a part of this settlement agreement and, therefore, will be void.

I will also forward a Certificate of Satisfaction to the PUC to inform them of the status of this complaint. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will sufficiently confirm to the PUC that the Complaint has been resolved and the file will be closed.
