
Dear Chairman Powelson;

I have filed a formal complaint against Duquesne Light CO. for the return of overcharges on my account due to a malfunctioning electric meter. This overcharge occurred during a period in 2012. The PUC appointed a brain dead lawyer named Hoyer to conduct a hearing on my complaint DLC assigned a staff attorney who perjured herself to defend DLC's position. My claim is for \$500.00, this amount will not cover my expense to retain an attorney, causing me to represent myself. In brief, DLC admitted that their measuring device malfunctioned during the period in question and credited me \$300.00 toward the \$800.00 due leaving a balance of \$500.00.

Hoyer, in setting the date of my hearing, had an exparte contact with DLC counsel Allison to accommodate her vacation. Allison then violated Hoyer's explicit directive to provide all documents to all parties by a certain date. She also lied by averring that she returned to me my \$200.00 check made payable to the PUC for your agency to conduct a test of my meter. In that regard, the PUC including, senior supervisors, disregarded the PA code by refusing my request. I will test Hoyer's and Allison's competency with the PA bar.

Please review this complaint and setup a new hearing with a fair presiding officer or direct DLC to credit my account with \$500.00.
