



Dear Attorney Allison:

Please be advised that on January 14, 2012, the Complainant, Mr. James E. Creehan, filed a letter with Chairman Robert Powelson of the Pennsylvania Public Utility Commission regarding his objections to his formal complaint at Docket Number C-2011-2231294. However, that case was adjudicated and closed in February of 2012. Mr. Creehan subsequently filed another formal complaint against Duquesne Light at Docket Number C-2012-2297124 on March 26, 2012, which has been litigated, and an Initial Decision served on the parties of record on January 11, 2013. Mr. Creehan has twenty (20) days from the date of service, or by the close of business (4:30 p.m. EST) on January 31, 2013, to file exceptions to the Initial Decision. Therefore, the attached letter will be considered as timely filed exceptions to the Initial Decision.

On further review of this matter, the Respondent, Duquesne Light, was not properly served with this filing made by Mr. Creehan. Therefore, in accordance with 52 Pa.
