BY THE COMMISSION:

Zody's Moving & Storage Co., Inc. (Carrier), furnishes household goods in use services originating in Franklin County as thoroughly described in their official tariff.

Carrier has filed the 2nd Revised Page 111 to Tariff Freight Pa. PUC No. 54, on October 10, 2005.

Carrier proposes to increase its hourly 3 men and vehicle normal complement charge by 12.6%. Carrier currently charges \$79.00 per hour and proposes an increase to \$89.00 per hour (12.6%). The current hourly rates have been in effect since May 28, 2001.

Carrier's total 2004 intrastate household goods revenue from operations is \$164,829 and the carrier's operating ratio is not less than 93%.

Carrier has submitted a tariff and documentation, in compliance with 52 Pa. Code §23.67(c), for carriers of household goods in use, with gross annual intrastate revenues of less than \$200,000.

ANALYSIS

In order to generate this revenue increase, Carrier proposes increases in its hourly charges. Carrier proposes to increase its 3 men and vehicle normal complement charge of \$79.00 per hour to \$89.00 per hour, which would be an increase of 12.6%.


CONCLUSION

We have determined that the increase is not an excessive amount based on the operating ratio. We believe that the increase will be sufficient to provide safe, dependable and continuous service to the public. The Carrier has no outstanding fines or assessment due; THEREFORE,
