
I am writing in regards to the notice we received today regarding the alleged lapse in our insurance coverage. We immediately contacted our insurance, Federated Insurance, and they were surprised at this notice. They stated they mailed the forms on January 7th to the correct address. They emailed a PDF copy of the forms that they sent and I immediately contacted the PUC and spoke to Wendy Yohe who provided me her email address and I forward the forms to her. I also requested of Federated to send another copy of the forms overnight to the correct address. They did overnight with tracking # 1Z 566 4X8 24 4837 8718. I also emailed the tracking number to Wendy Yohe (All copies of emails included). We never lapsed our insurance coverage and mailed the appropriate E and H forms as requested in a timely manner. I am requesting the PA PUC waive/remove the fine as we met our responsibility in full. Our old policy did not expire till January 8th and my understanding is Federated Insurance faxed for temporary notice, per your policy, by January 7th and had them in the mail that same day. I am concerned that when I spoke with Wendy earlier today she said our file is “empty”, as I understood without any proof of our current forms. The 24th is over 2 weeks from the point they were

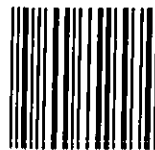
