# (a) TRISTATE HOUSEHOLD GOODS CONFERENCE, INC., MEMBERS IN LEHIGH AND NORTHAMPTON COUNTIES INCREASE IN RATES

(b) Tristate Household Goods Tariff Conference, Inc. (Tristate) has filed the 11<sup>th</sup> Revised Page 72 to Tariff Freight Pa. PUC No. 50 on March 14, 2007 and proposes a total increase in revenues of \$68,865 to cover increased wage and fringe benefit expenses for carriers in Lehigh and Northampton Counties. The current rates have been in effect since August 15, 2005. Tristate proposes to increase the hourly 3 men and vehicle normal complement charge by 3.4%, increasing the rate from \$116 to \$120 per hour. Fischer-Hughes of Allentown, Inc., Frick Transfer, Inc., Glose Moving & Storage, Inc., Keller Moving and Storage, Inc., Adam Meyer, Inc., and Diane Garland, t/a Shively's are the affected carriers. None of these carriers have outstanding fines or assessments. Tristate has submitted a wage/fringe benefit and insurance cost study for Lehigh and Northampton Counties in support of the proposed hourly increase indicating that employee wages and fringe benefits have increased by 4% from \$15.32 per hour in 2005 to \$15.94 per hour in 2007.

(c) The data compiled and submitted by the carrier supports this increase and the Bureau recommends that 11<sup>th</sup> Revised Page 72 to Tariff Freight Pa. PUC No. 50 be approved to become effective May 14, 2007.

## ORDER

### **BY THE COMMISSION:**

Tristate Household Goods Tariff Conference, Inc. (Tristate) has filed the 11<sup>th</sup> Revised Page 72 to Tariff Freight Pa. PUC No. 50 on March 14, 2007 and proposes a total increase in revenues of \$68,865 to cover increased wage and fringe benefit expenses for carriers in Lehigh and Northampton Counties. The current rates have been in effect since August 15, 2005.

Tristate proposes to increase the hourly 3 men and vehicle normal complement charge by 3.4%. The current hourly rate for Lehigh and Northampton Counties is \$116 per hour. Tristate proposes increasing this rate to \$120 per hour.

Fischer-Hughes of Allentown, Inc., Frick Transfer, Inc., Glose Moving & Storage, Inc., Keller Moving and Storage, Inc., Adam Meyer, Inc., and Diane Garland, t/a Shively's are the affected carriers that are subject to the 11<sup>th</sup> Revised Page 72 to Tariff Freight Pa. PUC No. 50 for Lehigh and Northampton Counties. None of these carriers have any outstanding fines or assessments.

Tristate has submitted a wage/fringe benefit and insurance cost study for Lehigh and Northampton Counties in support of the proposed hourly increase indicating that the increase is necessary to cover the cost of operating. Employee wages and fringe benefits have increased by 4% from \$15.32 per hour in 2005 to \$15.94 per hour in 2007.

## <u>ANALYSIS</u>

In order to generate this revenue increase, Tristate proposes to increase the 3 men and vehicle normal complement by 3.4% from a charge of \$112 per hour to \$116 per hour. We conclude that the data compiled and submitted by the carrier supports this increase.

## **CONCLUSION**

We have determined that Tristate has submitted the documentary justification to support the proposed revenue increase of \$68,865 and that the increase is not an excessive amount based on the increase in operating expenses. We believe that the increase will be sufficient for the carriers to provide safe, dependable and continuous service to the public: THEREFORE,
