IT IS ORDERED:

1. That the Formal Complaint filed by Martha V. Davis against PECO Energy Company at Docket No. F-01373792 is sustained in part, as provided below.

2. That PECO Energy Company shall cease and desist from advising its customers that their security deposits will be refunded, when the deposit is being or may be applied to the customers' account to reduce past due bills.

3. That PECO Energy Company shall, upon inquiry, inform customers of the criteria for security deposit refunds, set forth in 52 Pa. Code §56.53, and shall inform customers that their deposits may be applied to reduce arrearages, if timely payments of bills for service are not made.

4. That the Formal Complaint filed by Martha V. Davis against PECO Energy Company at Docket No. F-01373792 is in all other respects denied.


