EGS License Modification Request**

Dear Secretary Chiavetta:

By Order entered on January 24, 2013, the Pennsylvania Public Utility Commission ("Commission") approved the EGS Application of Park Power, LLC and issued a license authorizing Park Power to provide electric generation supply services to residential and small commercial customers in the territories of PECO Energy Company, PPL Electric Utilities Corporation, and Duquesne Light Company.

By this letter, Park Power, LLC respectfully requests that the Commission amend Park Power's EGS license as follows:

- To include the provision of electric generation supplier services to large commercial (> 25 kW) and industrial customers.
- To expand Park Power's license to include all EDC territories throughout the Commonwealth of Pennsylvania by adding the service territories of Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company, West Penn Power Company d/b/a Allegheny Power, UGI Utilities, Inc., Pike County Power & Light Company, Citizens Electric Company and Wellsboro Electric Company.

Please note that Park Power submitted proofs of publication for the Philadelphia Daily News, Harrisburg Patriot-News, Pittsburgh Post-Gazette, Scranton Times-Tribune, and Williamsport Sun-Gazette with its initial EGS Application. Enclosed herewith are proofs of


