On December 21, 2012, Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company and West Penn Power Company (collectively, "the First Energy Companies") filed a Joint Petition for Approval of their Smart Meter Deployment Plan with the Pennsylvania Public Utility Commission ("Commission").

The OSBA will participate in this proceeding to assure that the interests of small business customers are adequately represented and protected.

After an initial review of the materials submitted by the First Energy Companies, the OSBA has identified the following list of issues that it will evaluate in this proceeding, subject to time and budget constraints:

1. Whether the costs that the Companies seek to recover are "reasonable and prudent," as required by Section 2807(f)(7) of the Public Utility Code, 66 Pa. C.S. §2807(f)(7);

- 2. Whether the overall plan cost will reflect "operating and capital cost savings," as required by Section §2807(f)(7);
- 3. Whether the proposed cost recovery is likely to result in an appropriate recovery of costs from Small C&I customers;
- 4. Whether the costs to be recovered are being properly allocated among the rate classes; and
- 5. Whether the costs to be recovered are being properly allocated within the Small C&I classes.

The OSBA reserves the right to pursue additional issues as they arise throughout the proceeding.
