PREHEARING MEMORANDUM OF THE MET-ED INDUSTRIAL USERS GROUP, THE PENELEC INDUSTRIAL CUSTOMER ALLIANCE, THE PENN POWER USERS GROUP, AND THE WEST PENN POWER INDUSTRIAL INTERVENORS

As requested by Administrative Law Judge ("ALJ") Elizabeth H. Barnes in the January 30, 2013, Prehearing Conference Order, the Med-Ed Industrial Users Group ("MEIUG"), the Penelec Industrial Customer Alliance ("PICA"), the Penn Power Users Group ("PPUG"), and the West Penn Power Industrial Intervenors ("WPPII") (collectively, "Industrial Customer Groups") hereby submit this Prehearing Memorandum.

I. HISTORY OF THE PROCEEDING

On August 14, 2009, pursuant to the requirements of Act 129 and the Commission's Implementation Order entered on June 24, 2009, at Docket No. M-2009-2092655 ("I.O."), the Metropolitan Edison Company ("Met-Ed"), the Pennsylvania Electric Company ("Penelec"), the Pennsylvania Power Company ("Penn Power"), and the West Penn Power Company ("West Penn") (collectively, the "Companies") filed their Act 129 Smart Meter Technology Procurement and Installment Plans ("SMPI Plan") with the Commission. The Commission approved Met-Ed's, Penelec's and Penn Power's SMPI Plans, with modifications, on June 9, 2010, and approved West Penn's SMPI Plan on June 30, 2011.

The I.O. granted Electric Distribution Companies ("EDCs") a 30-month grace period to establish a smart meter deployment plan. On May 25, 2012, the Companies submitted a Petition to extend the grace period to December 31, 2012. The Industrial Customer Groups did not object to the requested time extension. On June 28, 2012, the Commission granted the Companies' Petition, thereby extending the grace period to December 31, 2012, for the Companies to submit their smart meter deployment plan.

On December 31, 2012, the Companies jointly petitioned the Commission for approval of their Smart Meter Deployment Plan ("Deployment Plan" or "Plan"). Specifically, the Companies requested that the Commission: (1) find that the Deployment Plan satisfies the requirements of Act 129 and the I.O.; (2) approve the proposed procurement and deployment of approximately 2.1 million smart meters; (3) authorize recovery of smart meter costs through the Companies' Smart Meter Technologies Charge ("SMT-C") Riders, including recovery of an additional \$5.1 million through West Penn's SMT-C Rider for expenditures made to develop its SMPI Plan between 2009 and 2010; and (4) authorize the Companies to create a regulatory asset for their meter stock that will be replaced by smart meters ("Legacy Meters"), and include the removal cost for these meters as a recoverable Operations and Maintenance ("O&M") expense in the SMT-C of each Company's SMT-C Rider. The Companies estimate the total costs of the Deployment Plan to be approximately \$1.258 billion. To recover these costs, the Companies have each implemented a SMT-C Rider and are not proposing any major changes to those Riders.

On February 7, 2013, the Industrial Customer Groups filed a Joint Petition to Intervene in this proceeding. A description of the Industrial Customer Groups is set forth in Paragraph 7 of the Industrial Customer Groups' Joint Petition to Intervene. The Industrial Customer Groups'

Joint Petition to Intervene awaits disposition by the ALJ.

II. ANTICIPATED ISSUES AND SUB-ISSUES

The Industrial Customer Groups are concerned with whether the Companies' Deployment Plan is in the public interest and whether the Deployment Plan is in accordance with Act 129, the I.O., and all other applicable statutes and regulations. In this proceeding, the Industrial Customer Groups plan to pursue issues regarding the terms and conditions of their electricity service, including any rate increases imposed as a result of the Companies' Deployment Plan. The Industrial Customer Groups anticipate pursuing these issues during this proceeding and also reserve the right to raise further issues and to respond to all matters raised by other parties.

III. PROPOSED WITNESSES

The Industrial Customer Groups are still evaluating whether they will present any witnesses in this proceeding. If the Industrial Customer Groups determine that they will present such witnesses, the Industrial Customer Groups will inform the ALJ and the other parties as soon as possible. The Industrial Customer Groups intend to participate in this proceeding through the submission of discovery, cross-examination of other parties' witnesses, and the submission of

briefs, exceptions and reply exceptions, if necessary.

IV. PROPOSED SCHEDULE AND DISCOVERY RULES

The Industrial Customer Groups do not oppose consolidation of these proceedings and do not oppose the procedural schedule set forth in the Commission's January 30, 2013, Prehearing Conference Order, assuming consolidation of the dockets. Additionally, the Industrial Customer Groups do not intend to participate in Public Input Hearings and will defer to the other parties regarding the necessity of such Public Input Hearings. The Industrial Customer Groups are prepared to discuss protective order issues and issues regarding the petitions to intervene of other parties. Finally, the Industrial Customer Groups will cooperate with the ALJ and the parties at the Prehearing Conference to develop appropriate discovery rules in accordance with the Commission's regulations and any directives issued by the ALJ.

V. POSSIBILITY OF SETTLEMENT

The Industrial Customer Groups are willing to participate in discussions with the other parties to amicably resolve the issues in this proceeding.
