MOTION FOR DEFAULT JUDGMENT

NOW COMES the Pennsylvania Public Utility Commission's ("Commission") Bureau of Investigation and Enforcement ("I&E"), by its counsel, and files this Motion for Default Judgment against Allegheny Coin Company, Inc. t/a Allegheny Telephone Company ("Respondent") pursuant to Section 5.103 of the Commission's regulations, 52 Pa. Code §5.103. In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on October 26, 2012, by filing a Complaint and serving it by first class mail to Respondent at 6245 Saltsburg Road, Pittsburgh, PA 15235.
2. In addition, by Secretarial Letter dated October 26, 2012, the Commission's Secretary's Bureau served I&E's Complaint by certified mail to Respondent at 6245 Saltsburg Road, Pittsburgh, PA 15235.
3. 6245 Saltsburg Road, Pittsburgh, PA 15235 is the last known mailing address that Respondent provided to the Commission.
4. On November 13, 2012, the Complaint was returned to the Commission by the United States Post Office and was marked as "Return to Sender/ Not Deliverable as Addressed/ Unable to Forward."

5. By Secretarial Letter dated November 15, 2012, the Complaint was re-served to Respondent at 6245 Saltsburg Road, Pittsburgh, PA 15235.
6. On January 4, 2013, the Complaint was again returned to the Commission by the United States Post Office and was marked "RTS/Unable to Forward."
7. I&E published the Complaint in the Pennsylvania Bulletin pursuant to the Commission's procedural regulations. 52 Pa. Code §1.53(e)(related to Service by the Commission).
8. The Complaint was published in the Pennsylvania Bulletin on January 19, 2013. 43 Pa. Bull. 402 (January 19, 2013).
9. Included with the Complaint was a Notice advising Respondent that it must file an Answer within twenty (20) days.
10. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.
11. Respondent's Answer was due on or before February 8, 2013, which was twenty (20) days after publication of the Complaint in the Pennsylvania Bulletin.
12. Respondent did not file an Answer to the Complaint.
13. Pursuant to Section 5.61(c) of the Commission's regulations, a Respondent who fails to file an Answer to a Complaint within the 20-day response period may be deemed in default, and the relevant facts stated in the Complaint may be deemed admitted. 52 Pa. Code §5.61(c).
14. The Commonwealth Court has upheld the Commission's authority to sustain complaints that are not answered within twenty days. *See Fusaro v. Pa. PUC*, 382 A.2d 794, 797 (Pa. Cmwlth. 1978).
15. In the Complaint, I&E alleged that Respondent failed to pay its assessment for the 2009-2010, 2010-2011 and 2011-2012 fiscal years and owes \$1,118.
16. I&E also alleged that Respondent failed to file assessment reports to demonstrate its gross intrastate operating revenues for the 2010 calendar year.
17. I&E proposed a civil penalty of \$1,165 for Respondent's failure to file assessment reports and timely pay its assessment.

18. Respondent has not paid the outstanding assessment amount or civil penalty that was requested in the Complaint.

19. WHEREFORE, I&E respectfully requests that the Commission enter a Default Order against Respondent that:

- a. Orders Respondent to pay its outstanding assessment and civil penalty;
- b. Cancels Respondent's certificate of public convenience; and
- c. Directs the Bureau of Administrative Services, Assessment Section to refer the matter to the Pennsylvania Office of Attorney General for collection of the unpaid assessments.




