Dear Respondent:

On May 13, 1999, the Bureau of Transportation and Safety instituted a Complaint against Mooney's Relocation Specialists, respondent, alleging failure to pay outstanding assessments of \$11,294.00, a violation of the Public Utility Code at 66 Pa C.S. §510(c).

In accordance with 52 Pa. Code §5.61, the Notice of the Complaint notified respondent that it must file an Answer to the Complaint within twenty (20) days of the date of service. The Notice further specified that, if respondent failed to answer the Complaint within twenty (20) days, the Bureau of Transportation and Safety would request the Commission to cancel respondent's certificate of public convenience, direct the Pennsylvania Department of Transportation to revoke the motor vehicle registrations issued to respondent, notify the Pennsylvania Department of Revenue that respondent's certificate is revoked and notify respondents insurance carrier the respondent's certificate is revoked.

The Complaint was served on respondent, Mooney's Relocation Specialists, on or about May 17, 1999. To date, more than twenty (20) days later, respondent has failed to file an Answer to the Complaint.

Therefore, the allegations in the Complaint are deemed to be admitted. The Complaint is hereby sustained and the Certificate of Public Convenience, issued to Respondent at A-00106317 is hereby canceled.


