(b) Mooney's Relocation Specialist, Inc. (Carrier), furnishes household goods in use services originating in Montgomery County as thoroughly described in its official tariff. Carrier has filed Tariff Freight Pa. PUC No. 12 on June 27, 2005. The carrier proposes a total increase in revenues of \$39,370 of which \$34,554 would come from intrastate revenues and \$4,816 would come from interstate revenues. The proposed increase is to cover increased insurance premiums and advertising costs. Carrier proposes to increase its hourly 3 men and vehicle normal complement charge by 6.7%. Carrier currently charges \$105 per hour and proposes an increase to \$112 per hour (6.7%). The current hourly rates have been in effect since October 6, 2003. There are currently no outstanding fines or assessments.

(c) The Bureau recommends that Tariff Freight Pa. PUC No. 12 be approved to become effective on August 29, 2005.

(b) Mooney's Relocation Specialists, Inc. (carrier) furnishes household goods in use services originating in Montgomery County, as more thoroughly described in the order which grants authority at Docket No. A-00106317. Carrier has filed Tariff Freight Pa. P.U.C. No. 13. The carrier proposes an increase of \$46,254 in intrastate revenues by increasing the hourly 3 men and vehicle normal complement charge from \$112 per hour to \$122 per hour. The current hourly rates have been in effect since August 29, 2005. There are currently no outstanding fines or assessments.

(c) The data compiled and submitted by the carrier supports this increase and the Bureau recommends that Tariff Freight Pa. P.U.C. No. 13 be approved to become effective October 27, 2008.
