**ORDER**

**BY THE COMMISSION:**

Forest Hills Transfer and Storage, Inc., has filed 9<sup>th</sup> Revised Page 27 Tariff Freight Pa. PUC No. 7 on February 25, 2004 and proposes a total increase in revenues of \$ 5,323 to cover increased operating expenses. The current rates have been in effect since June 17, 2002.

Carrier proposes to increase its hourly 3 men and vehicle normal complement charge by 10.6%. Carrier currently charges \$85.00 per hour and proposes an increase to \$94.00 per hour.

Carrier's total 2003 household good revenue from operations is \$3,715,576. Carrier's total interstate revenue is \$3,458,406. Carrier's total intrastate revenue is \$129,203 (the revenue effected by the hourly proposal herein is \$50,218).

Carrier has submitted a tariff and documentation, in compliance with 52 Pa. Code §23.67(c), for carriers of household goods in use, with gross annual intrastate revenues of less than \$200,000.

## ANALYSIS

In order to generate this revenue increase, Carrier proposes to increase its 3 men and vehicle normal complement charge of \$85.00 per hour to \$94.00 per hour. We conclude that the data compiled and submitted by the carrier supports this increase.

Staff review of Commission records reveals that The Snyder Brothers Moving, Inc., 5<sup>th</sup> Revised Page 44 to Tariff Freight Pa. PUC No. 54, effective December 23, 2002 is charging \$94.00 per hour. McKean & Burt, Inc., 4<sup>th</sup> Revised Page 14-A to Tariff Freight Pa. PUC No. 54, effective June 30, 2003, is charging \$95.00 per hour. Quality Movers East, Inc., 2<sup>nd</sup> Revised Page 83-A to Tariff Freight Pa. PUC No. 54, effective September 16, 2002, is charging \$98.00.


## CONCLUSION

We have determined that Forest Hills Transfer and Storage, Inc., has submitted the documentary justification to support the proposed revenue increase of \$5,323, and that the increase is not of an excessive amount based on the operating ratio. The carrier avers that the increase will be sufficient to provide safe, dependable and continuous service to the public: THEREFORE,

### **IT IS ORDERED:**

1. That 9<sup>th</sup> Revised Page 27 to Tariff Freight Pa. PUC No. 7 be approved to become effective May 31, 2004.
2. That a copy of this order be served upon the carrier.
