These comments to the above-captioned Petition are submitted on behalf of Reliant Energy Northeast LLC ("Reliant"). On February 22, 2013, PECO Energy Company filed its Petition for expedited approval of certain revisions to its Initial Dynamic Pricing and Customer Acceptance Plan. Reliant supports PECO's Petition and requests that the Commission act expeditiously in approving the revisions to PECO's Plan.

Reliant is the company PECO has selected to be the initial EGS to provide time-of-use service and to provide program management. As PECO noted in its Petition, expedited consideration is required because: (1) the customer premises testing component of the Technology Plan must be completed before CAP customers in the pilot can receive their In Home Devices; and (2) a wide range of administrative, marketing and IT projects must be completed before customers may be solicited to enroll in the pilot's TOU rate offer.

Reliant supports PECO's Petition for expedited treatment and agrees with PECO's assessment of the importance of beginning the process of implementing its Plan as soon as possible.


