RE: Financial Security Requirements

Dear Mr. Fisher

UGI Utilities, Inc. (“UGIU”) has received the initial amount of security as specified in the UGI Central Penn Gas, Inc. (“CPG”) and UGI Penn Natural Gas, Inc. (“PNG”) Supplier Coordination Tariffs from Mirabito Natural Gas, LLC. (“Mirabito”). As a result, UGIU has determined that Mirabito has initially demonstrated adequate creditworthiness to satisfy any costs PNG or CPG may incur in the event they operate as suppliers of last resort due to a default on the part of Mirabito.

This determination may change in the event there is a material deterioration in Mirabito’s financial condition, if Mirabito’s obligations to PNG and CPG exceed the amount of the financial security provided, if the financial security is withdrawn or is deemed to be null and void or inadequate due to the material financial deterioration of any guarantor, or if Mirabito fails to abide by the terms and conditions of the CPG and PNG Gas Tariffs and the CPG and PNG Natural Gas Supplier Coordination Tariffs.

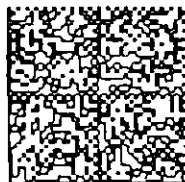
